### **Business and Human Rights Gateway**

§ 290. Purposes of article. 1. This article shall be known as the "Human Rights Law". 2. It shall be deemed an exercise of the police power of the state for the protection of the public welfare, health and peace of the people of this state, and in fulfillment of the provisions of the constitution of this state concerning civil rights.
