Causes and Targets of Human Trafficking. CAUSES: Conditions facilitating recruitment of women include:- economic desperation and disadvantage- lack of a sustainable income, and poverty--all of which are preyed on by recruiters, traffickers and pimps. Reported push factors were: Economic and oppressive conditions in countries of origin.

Causes & Effects of Human Trafficking

The term human trafficking is defined by as a trade of humans, most commonly for sexual slavery, forced labor or bonded labor and commercial sexual exploitation for traffickers or others. They may extract organs or tissues or provide a spouse for forced marriage. This type of crime can occur locally, nationally or internationally.

Top 5 Causes of Human Trafficking. Initiatives to diminish these causes of human trafficking include international cooperation agreements, national policies against trafficking, improved immigration policies that can detect the exit or entry of humans being illegally trafficked, and increased infrastructure to protect those that are being exploited for labor or sex.
